The Indian Parliament has amended the Indian Constitution ninety-seven times since its ratification in 1950 Fundamental Rights in India were amended frequently, specifically the right to private property, which was deleted in 1978 through the Forty-Fourth Amendment These amendments gradually removed the constitutional constraints
